1. REACH (Registration, Evaluation, Authorisation, and Restriction of Chemicals) Regulation (EC) No 1907/2006:
  - We endeavour to uphold our products do not contain Substances of Very High Concern (SVHCs) listed in the Candidate List above the 0.1% threshold, and all substances used are in compliance with the requirements of REACH.
2. RoHS (Restriction of Hazardous Substances Directive) 2011/65/EU and (EU) 2015/863:
  - We endeavour to uphold our products comply with the RoHS Directive, ensuring that restricted substances (including lead, mercury, cadmium, hexavalent chromium, PBBs, and PBDEs) are not present above the permitted levels in our materials.
3. California Proposition 65 (Safe Drinking Water and Toxic Enforcement Act of 1986):
